

Competition & Giveaway Terms

1. Introduction

From time to time, The Daily Round may run competitions, giveaways, prize draws, promotions, campaigns, nominations, awards, or other promotional activities across its website, newsletters, social media channels, events, or related platforms.

These Competition & Giveaway Terms apply to all such activities unless separate terms are provided for a specific promotion.

By entering or participating in a competition, giveaway, prize draw, or promotional activity operated by The Daily Round, participants acknowledge that they have read, understood, and agreed to these terms together with any additional promotion-specific requirements or instructions.

The Daily Round aims to operate competitions and promotional activities fairly, transparently, and responsibly while maintaining appropriate editorial and operational standards.

Participation in any competition, giveaway, or promotion is subject to:

- eligibility requirements,
- entry instructions,

5. Prize Information
